

Inquiry for offers no. 36

Zakłady Magnezytowe "ROPCZYCE" S.A. announces an inquiry for offers for the execution of the task: "Purchase of raw materials for the execution of trials on a semi-technical and industrial scale".

The procedure is executed on the basis of the current Guidelines in force concerning qualification of expenses under the European Regional Development Fund, European Social Fund and Compatibility Fund for the years 2014-2020, whilst giving consideration to the necessity to make purchases on the basis of the most favourable offer from the economical point of view, preserving the principles of fair competition, effectiveness, openness and transparency.

The task is executed within the framework of the Smart Growth Operational Program (SGOP), Priority Axis 2: Support for the environment and potential of enterprises for management of the R&D&I, Action 2.1 Support of investments in the R&D infrastructure, a contest organized by the Ministry of Development.
